New Business

Fall Conference 2006:

After considerable discussion, the membership decided to stay one more year at Inn by the Lake even though this year's numbers were up and more expected at the conference next year. Possibly breakout sessions will be considered, but generally, everyone likes the facilities and the staff is excellent. The next conference dates will be posted on the website as soon as they are confirmed with the Inn.

Division of Aeronautics Position:

The discussion centered on Austin Wiswell's position to be vacant due to his retirement on September 30, 2005. The membership agreed that the position must have someone that understands airports; aeronautics should be a priority; and ACA should take lead. It was agreed that ACA would prepare a letter that would express our concerns. Information on value of aviation that is on the Aeronautics website will be used to show the importance of aviation for the individual selected in this position. The letter will be posted on the ACA website.

Legislative Update

John Pfeifer gave a summary report of legislation:

AB 1101 died in committee – this bill would attack any diesel activity and mainly directed towards LAX and Oakland; but, if passed could have next went after aircraft emissions

AB 556 died in committee – this bill would require variance for 65 cnel or more

SB 335 – sales tax on general aviation jet fuel (amounts to about \$7 million historically) – bill would provide a stable revenue source for the Division for the next 5 years – money was stripped out and then it was approved

AB 1358 – Charter school bill – passed September 6 and has been signed by the Governor

General Discussion:

Two presentations were made: one to John Swizer, outgoing Treasurer and Mark Bautista, outgoing President.

There being no further business, the meeting was adjourned at approximately 5:10 pm.
